NOTICE OF RACE

NB: The notation '[DP]' in a rule in the Notice of Race means that the penalty for a breach of that rule may, at the discretion of the protest committee, be less than disqualification.

1 RULES

- 1.1 The Club Champs will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 The Yachting New Zealand Safety Regulations Part 1 shall apply.
- 1.3 Appendix T will apply. For protests where only a Rule of Part 2, or Rule 31 is alleged to have been broken an arbitration hearing will be offered prior to any formal hearing.

2 ADVERTISING

- 2.1 Boats may be required to display advertising chosen and supplied by the organising authority. If this rule is broken, World Sailing Regulation 20.9.2 applies. [DP]

3 ELIGIBILITY AND ENTRY

- 3.1 The Club Championship is open to boats of all classes that are sailed by Financial Members of the Manly Sailing Club who will be automatic entries. Non Club members may compete on a daily basis in the "All comers" section of each division.
- 3.2 The age limits for each competitor, entrant and crew members shall be as follows:-
 - (a) Open Skiff: As per Class Rules

- (b) Starling: **Youth**, As per Class Rules
 - (c) Laser Radial: **Youth**, Under 19 as at 31 December 2020
Open, unrestricted
 - (d) Laser 4.7: **Youth**, Under 19 as at 31 December 2020
 - (e) Feva: **Youth**, As per Class Rules
Open, unrestricted one or both sailors
 - (f) 29er **Youth**, Both sailors Under 19 as at 31 December 2020
 - (g) Hobie: **Open** Unrestricted
 - (h) Zephyr: **Open** Unrestricted
 - (i) Windfoilers **Open** Unrestricted
- Other classes may be added

5.2 Number of races: Up to Five (5) races may be sailed each day

5.3 The scheduled time of the warning signal for the first race each day is 1255hrs

5.4 A briefing will be held at 1200hrs each race day.

6 MEASUREMENT

Class boats shall comply with RRS 78.1 at all times.

7 SAILING INSTRUCTIONS

The sailing instructions will be available online from Thursday October 10th 2019

8 VENUE

The racing area is Polkinghorne's Bay/Waiiau Bay Manly Whangaparaoa.

9 THE COURSES

The courses, the order in which marks are to be passed, and the side on which each mark is to be left will be advised at the briefing on each Race day.

10 PENALTY SYSTEM

10.1 The Scoring Penalty, Rule 44.3, will apply. After a protest a boat that is found at fault may be given a discretionary scoring penalty by the protest committee. The scoring penalty shall be no greater than 30% calculated as stated in Rule 44.3

10.2 For the Open Skiff, Feva and 29er classes RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

11 SCORING

11.1 a) Non Club Members will be scored in an "All Comers" Class division that will include club members for each class division.
b) Financial Club Members will be scored separately in each of their Class divisions

11.2 Twenty (20) races are required to be completed to crown a Club Champion.

11.3

- a) When twenty (20) races have been completed, a boat's series score will be the total of her race scores.
- b) When 21 to 30 races have been completed, a boat's series score will be the total of her race scores excluding her worst three (3) scores.
- c) For every 5 races completed from 30 an additional worst score will be excluded.

12 SUPPORT BOATS

Support/Coach boats will be permitted and shall have a working VHF radio for communications with the Race Committee in the event of marginal conditions, sailors in trouble and or injury to sailors.

13 PRIZES

At the conclusion of the Club Championship series Medals will be awarded as follows:

Open Skiff Gold:	1 st , 2 nd and 3 rd
Open Skiff Silver	1 st , 2 nd and 3 rd
Starling	1 st , 2 nd and 3 rd
Laser Radial Youth	1 st , 2 nd and 3 rd
Laser Radial Open	1 st , 2 nd and 3 rd
Laser 4.7 Youth	1 st , 2 nd and 3 rd
Feva Youth	1 st , 2 nd and 3 rd
Feva Open	1 st , 2 nd and 3 rd
29er	1 st , 2 nd and 3 rd
Hobie	1 st , 2 nd and 3 rd
Zephyr	1 st , 2 nd and 3 rd
Windfoilers	1 st , 2 nd and 3 rd

14 INSURANCE

Each participating boat is encouraged to be insured with valid third-party liability insurance with a minimum cover of \$1,000,000 per incident or the equivalent..

15 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organising authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
